Other colleges include student services in their discussion of online education

Important overlap of student services with online education/ distance ed department function.

Budget development—is part of the 10+1. Where does our college have a process for resource allocation for online education? Could we be making recommendations to support that as a formal process?

Issue of the non-instructional use of the LMS—still supports student success, needs to be accessible, etc. We currently have no support for this. (Clubs, affinity groups, STEM groups) We also use it for the faculty evaluation process.
